TUITION PAYMENT POLICY

The tuition for participation in NJSCC choirs covers all vocal instruction, rehearsals, concerts, music, and costs incurred for instruction and facility rental. Concert clothing and admission to concerts for family and guests are not included in the tuition.

Each of the NJSCC choirs functions as a team in which every member is important. Significant effort and resources are spent on choosing music and events to best fit all our singers. Because every singer is expected to fulfill his or her commitment for the entire season, tuition is non-refundable.

The tuition for the September to June season (approximately 40 weeks) is:

Apprentice Choir (grades K-2)- \$650 (as low as \$68.75/month for 8 months)

Intermediate Choir (grades 3-5)- \$750 (as low as \$81.25/month for 8 months)

There is a **sibling discount** of 20% applicable to the younger sibling's tuition.

Each chorister's place in the Chorus will be reserved by a check made out to NJSCC for the non-refundable Registration Fee of \$50 that is due with the registration form soon after acceptance by the chorus. The Chorus prepares and budgets for each year based on the number of children accepting the invitation to join the Chorus. The full tuition amount for the year is due and payable even if a child does not complete the season.

All tuition payments are made using FACTS Tuition Management System. Once the registration forms are completed and submitted, families must register with FACTS online by following the link below. When you register you choose your payment plan and payment type (bank ACH draft, credit or debit card, or invoice) for each of your choristers. You will have one account but will enter each chorister separately. Once your account and tuition fees have been verified by NJSCC, FACTS will begin invoicing. Payment Plans:

Using the FACTS system allows us to offer families multiple payment options:

1. Payment in full upon registration
2. \$100 by June 15, balance by September 1 (\$10 service fee)
3. \$100 by June 15, up to eight equal monthly payments beginning July (\$45 service fee)

There is a \$30 fee for payments returned unpaid from the bank.

There will be a \$25 late fee charged for payments which are received more than 30 days after the due date unless other arrangements have been made with the Chorus Manager in advance. In addition, if a tuition payment is late more than 30 days, the chorister will be unable to participate in rehearsals, performances or other events until the account is up to date.
